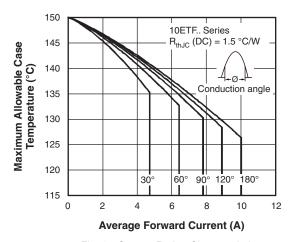


Fig. 1 - Current Rating Characteristics

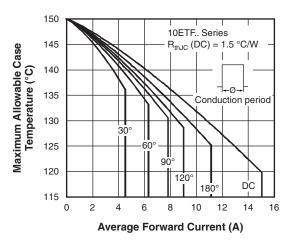


Fig. 2 - Current Rating Characteristics

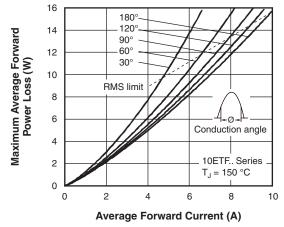


Fig. 3 - Forward Power Loss Characteristics

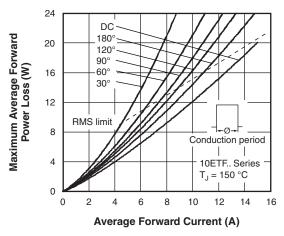


Fig. 4 - Forward Power Loss Characteristics

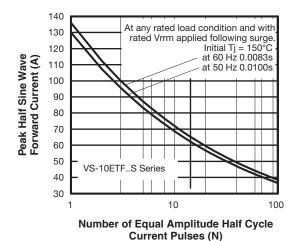


Fig. 5 - Maximum Non-Repetitive Surge Current

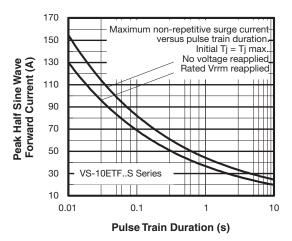


Fig. 6 - Maximum Non-Repetitive Surge Current

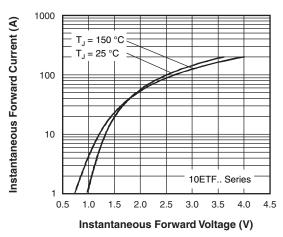


Fig. 7 - Forward Voltage Drop Characteristics

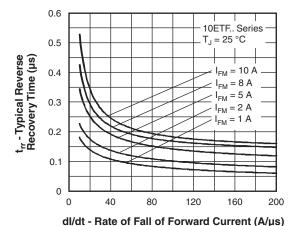


Fig. 8 - Recovery Time Characteristics, $T_J = 25$ °C

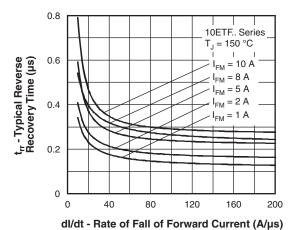
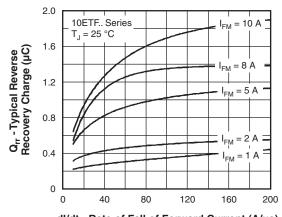
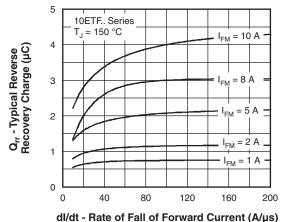


Fig. 9 - Recovery Time Characteristics, $T_J = 150 \, ^{\circ}\text{C}$



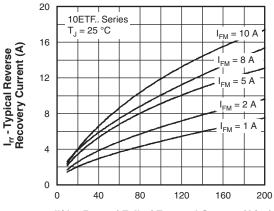
dl/dt - Rate of Fall of Forward Current (A/µs)

Fig. 12 - Recovery Current Characteristics, $T_J = 25 \, ^{\circ}\text{C}$

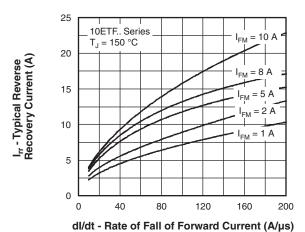


Fig. 13 - Recovery Current Characteristics, $T_J = 150 \, ^{\circ}\text{C}$

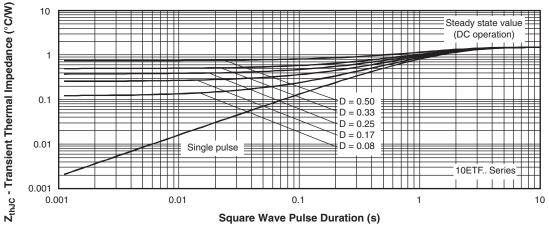
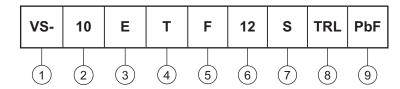


Fig. 14 - Thermal Impedance Z_{thJC} Characteristics
