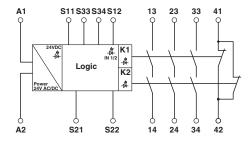

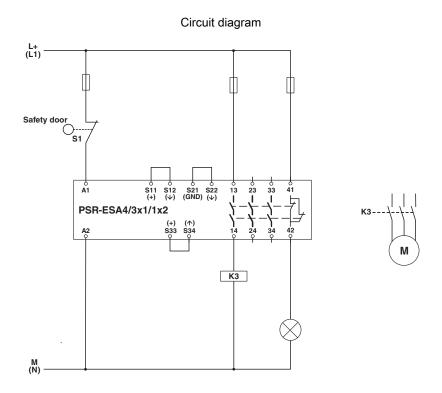

Circuit diagram

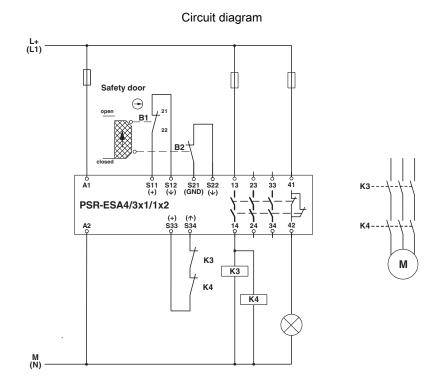






Single-channel safety door monitoring

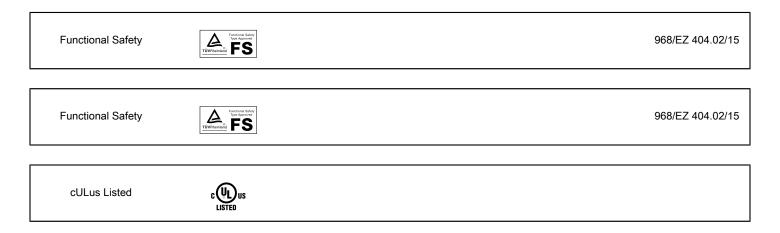
