


Fig. 1 - Maximum Forward Current Derating Curve




Fig. 2 - Maximum Non-Repetitive Peak Forward Surge Current




Fig. 3 - Typical Forward Voltage




Fig. 4 - Typical Reverse Current





Fig. 5 - Typical Junction Capacitance
