





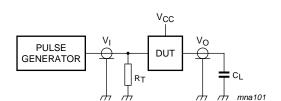






Fig 8. Package outline SOT753 (SC-74A)
