1. General description

The 74LVC86A provides four 2-input EXCLUSIVE-OR functions. It is a high-performance, low power, low-voltage, Si-gate CMOS device and superior to most advanced CMOS compatible TTL families.

Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V applications.

- 5 V tolerant inputs for interlacing with 5 V logic
- Supply voltage range from 1.2 V to 3.6 V
- CMOS low power consumption

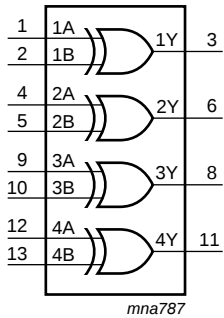


Fig 1. Logic symbol

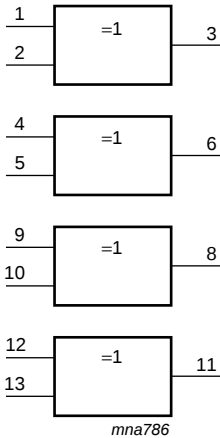


Fig 2. IEC logic symbol

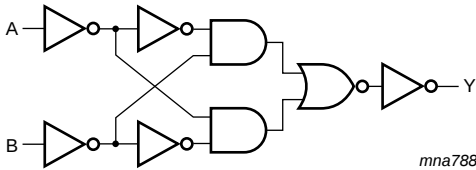
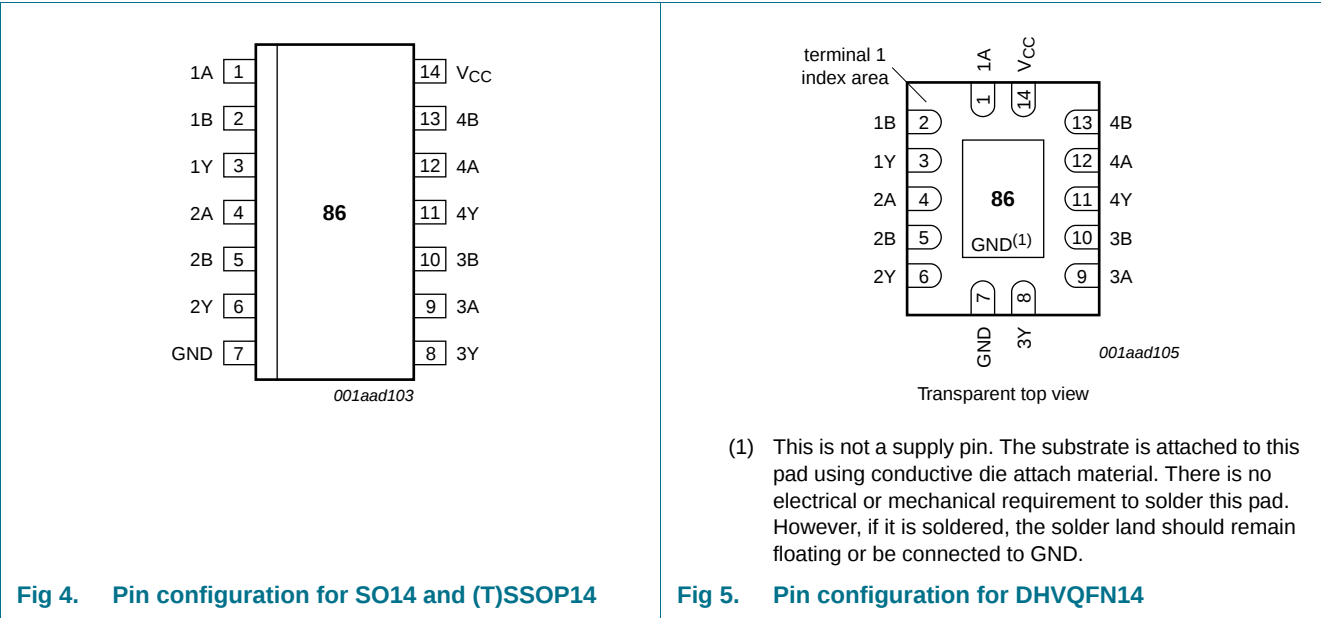


Fig 3. Logic diagram for one gate

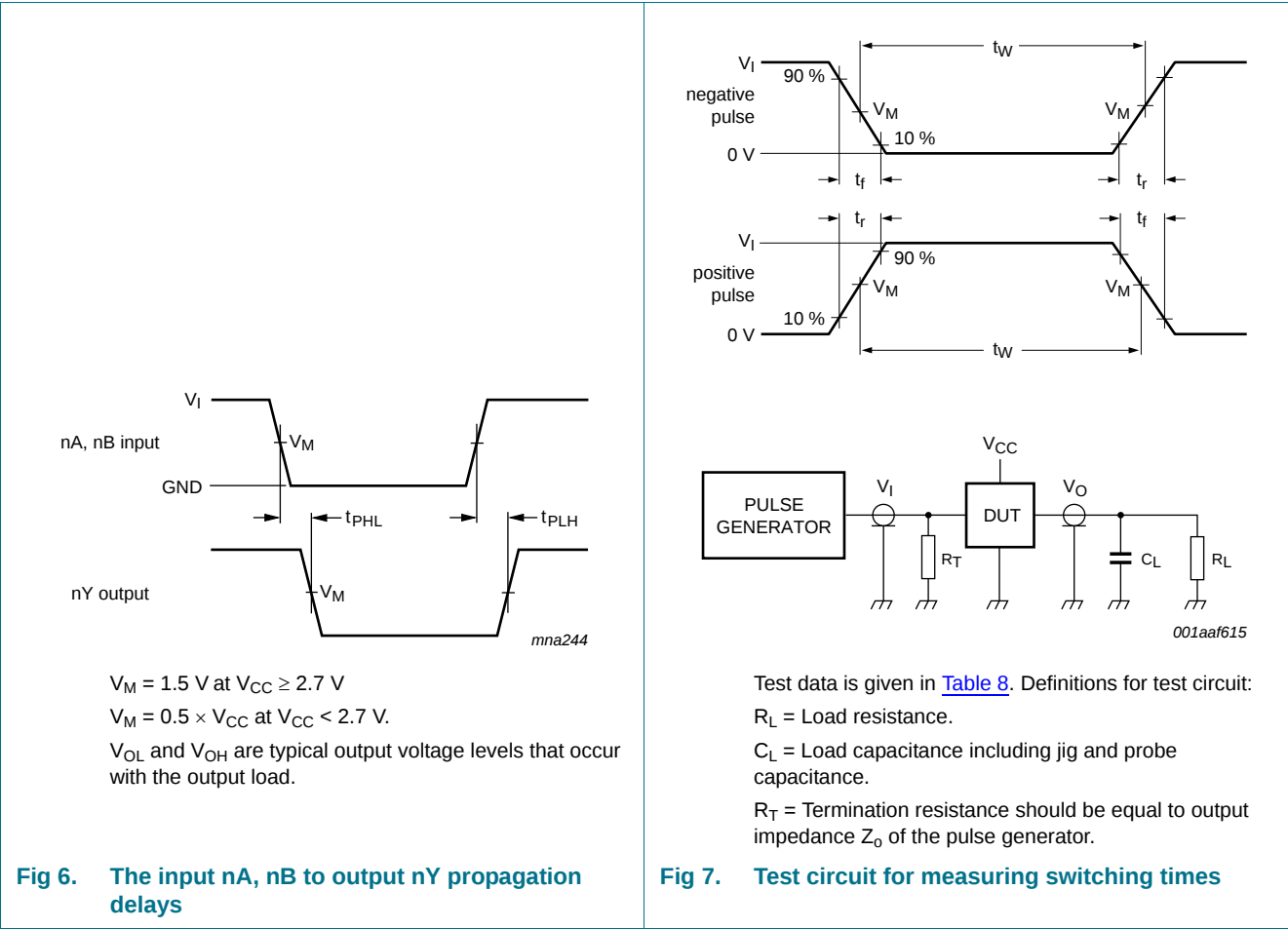

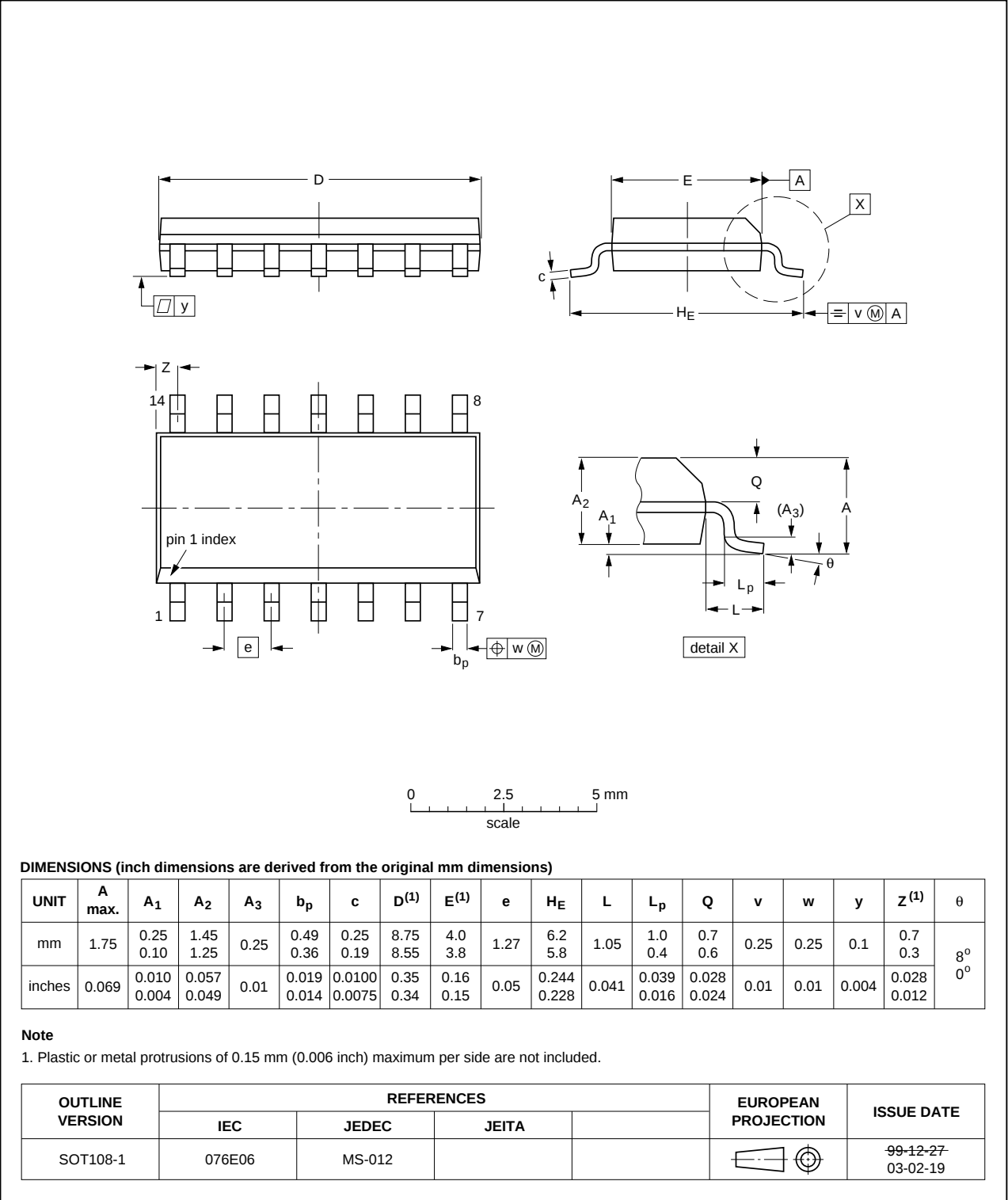


Fig 8. Package outline SOT108-1 (SO14)

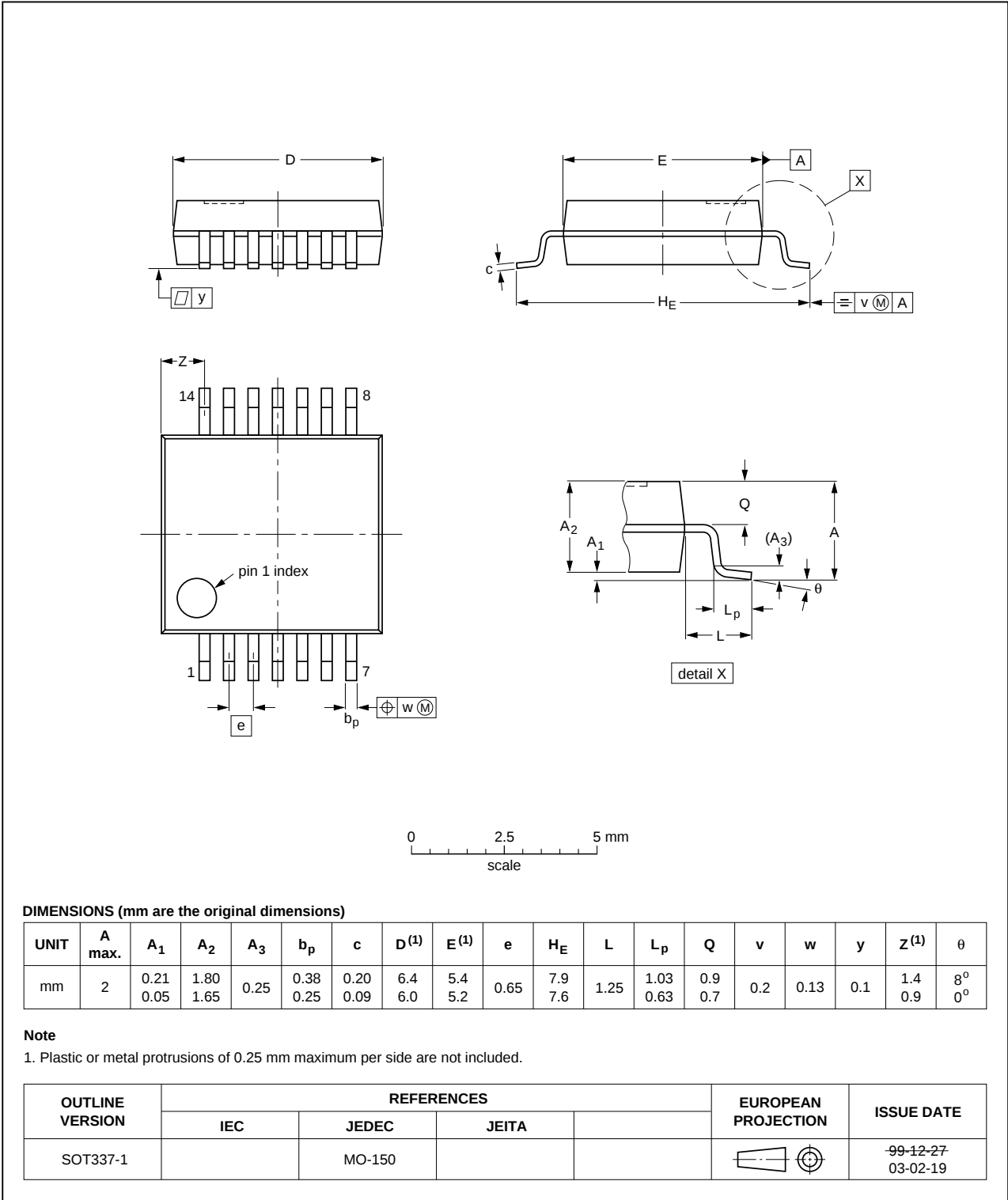


Fig 9. Package outline SOT337-1 (SSOP14)

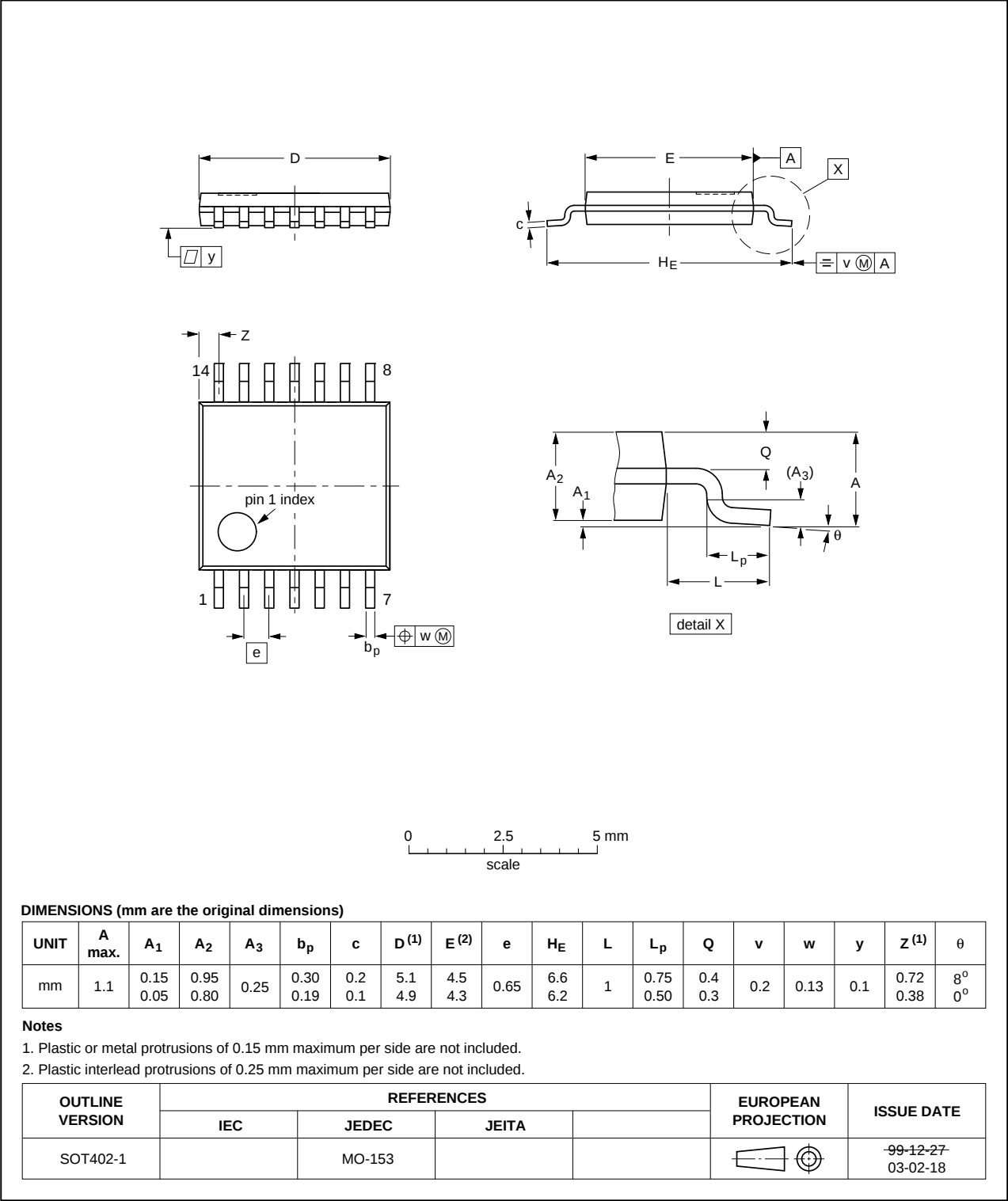


Fig 10. Package outline SOT402-1 (TSSOP14)

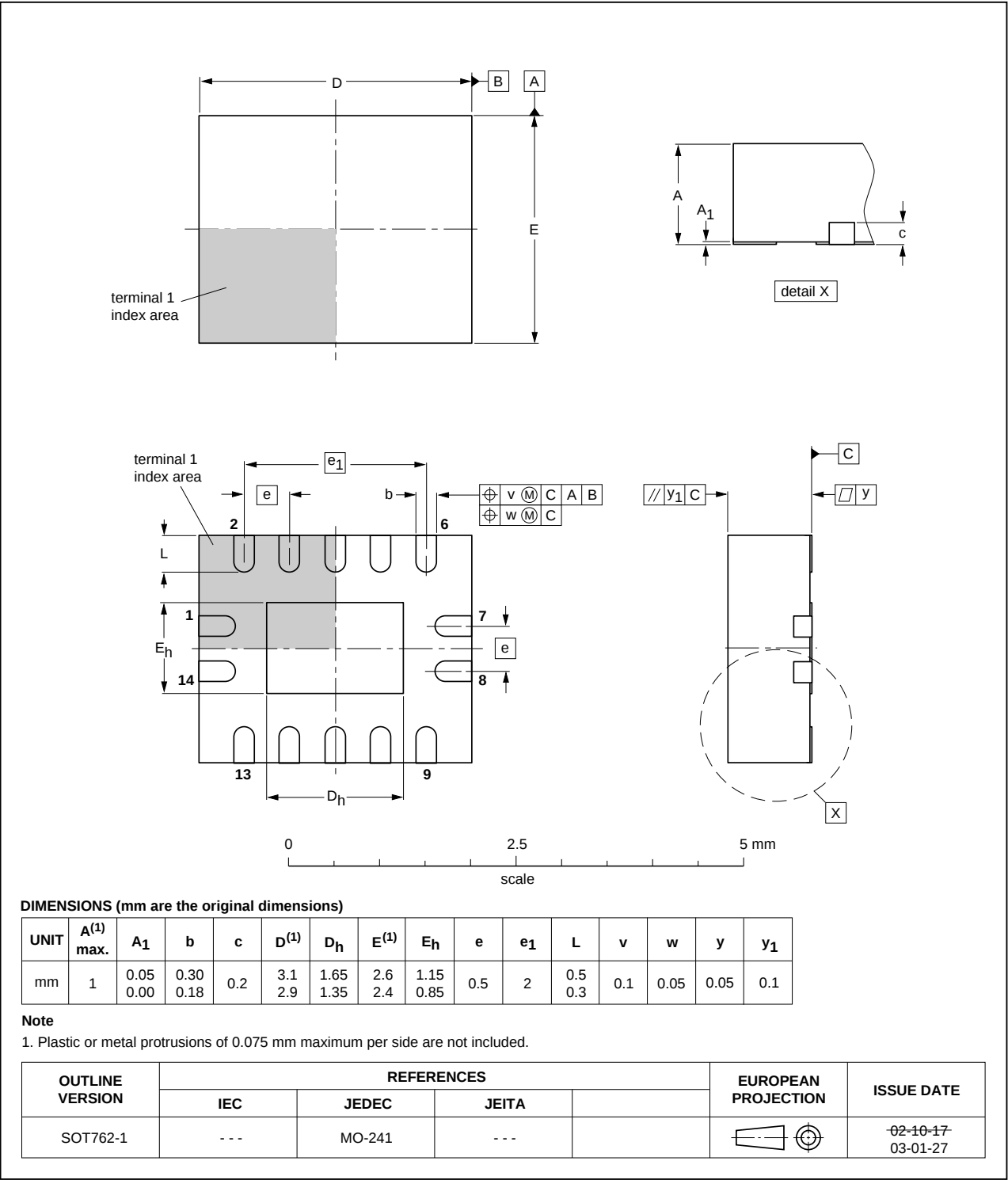


Fig 11. Package outline SOT762-1 (DHVQFN14)
