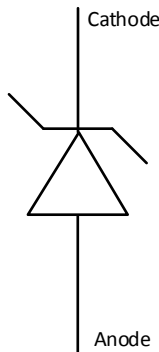

Peak Pulse Power and Current Derating:



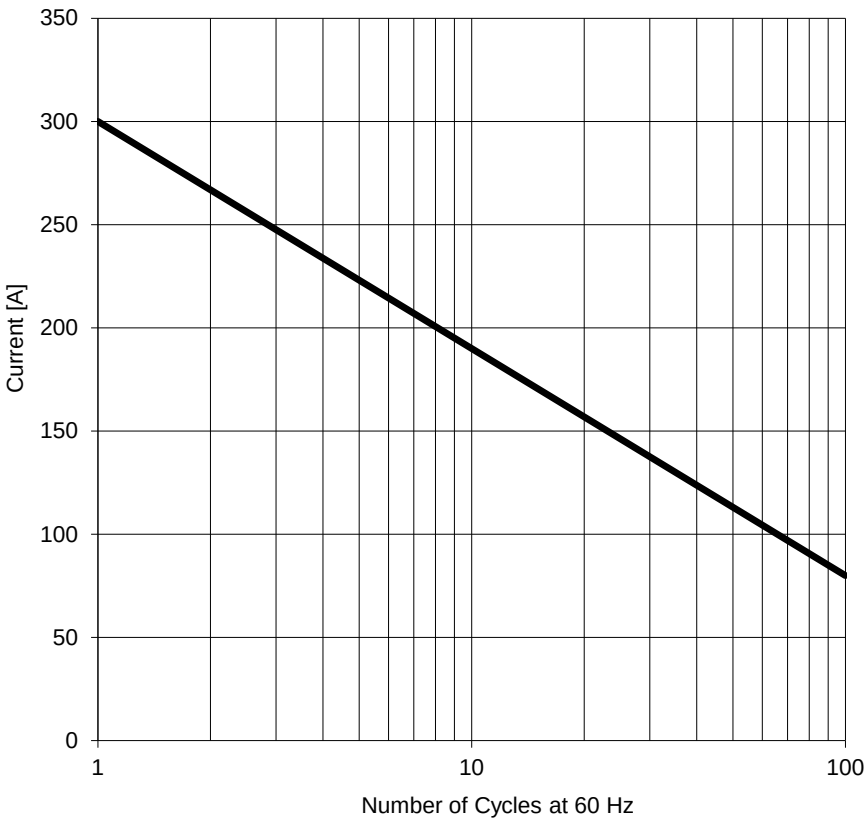
Steady State Power Dissipation Derating:



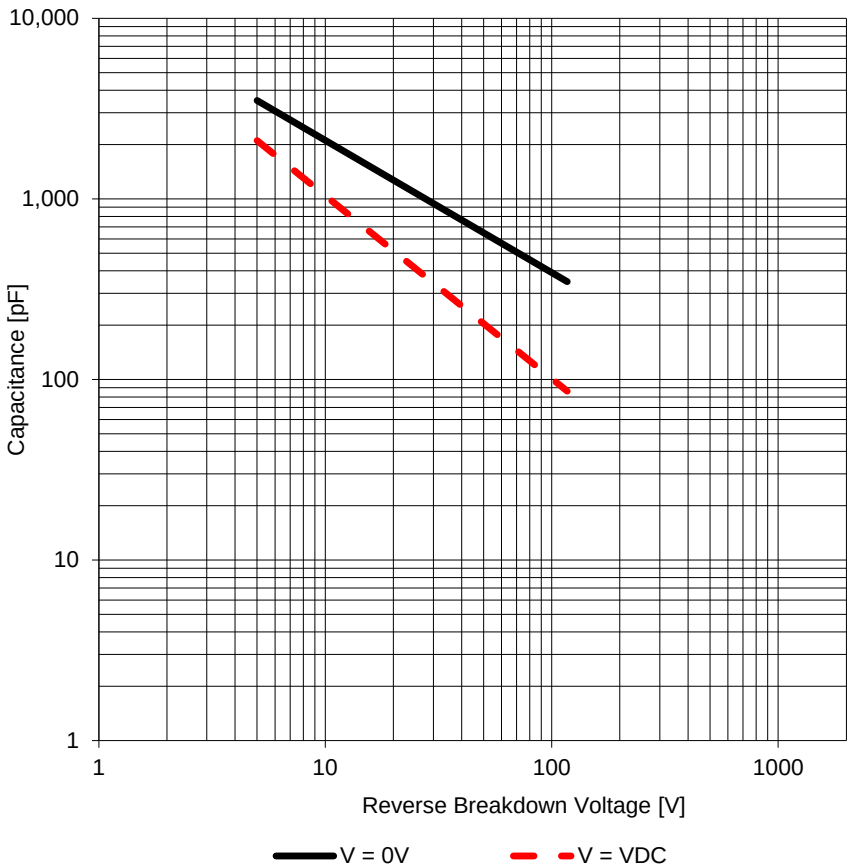
