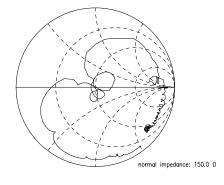


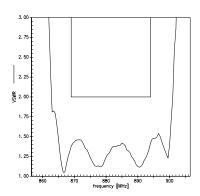
# S<sub>11</sub> function
