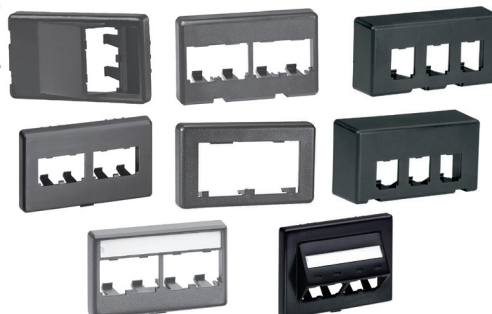


Mini-Com® Modular Furniture Faceplates

Modular furniture faceplates shall be available in multiple port densities, flat or sloped, with or without label pocket. Select furniture faceplates shall mount to standard and/or custom furniture openings depending on the furniture manufacturer it's compatible with. Furniture faceplates will accept any Mini-Com® Module.

Bend radius control	Bend radius can be protected or improved by using a sloped design or the faceplate extender, which will add 0.5" to the in-wall depth
Identification	Select faceplates include label pockets with labels and label covers for easy identification of ports; optional adhesive labels available
Various port densities	Provides design flexibility

applications

The 2 and 4 position furniture faceplates (CFFP4**, CFFPL4**, CFFPLA4**, and CFFPA2**) are used in work areas with modular furniture which have the TIA/EIA standard furniture outlet opening. Modular furniture manufacturers like Herman Miller^ and Knoll^ have custom openings for various models of furniture. The CFFPHM4** can be used with Herman Miller Action Office 2 and 3, and Baseline furniture series. The

CFFPEBSL4** is designed to work with the Ethospace Beltline series, and is a 4-position sloped faceplate. Knoll Equity^ furniture can utilize CFFPKE3**, which is a 3-position furniture faceplate that is extended off the face of the furniture. Also offered is a comparable 3-position faceplate, CFFPE3**, which adapts to Knoll's Morrison^^ Series, in addition to the TIA/EIA standard opening.

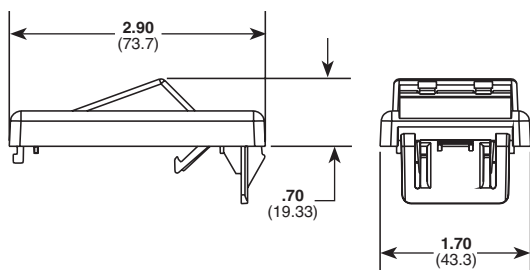

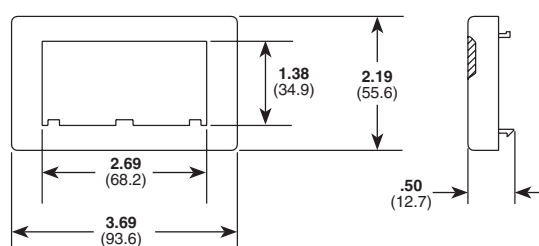

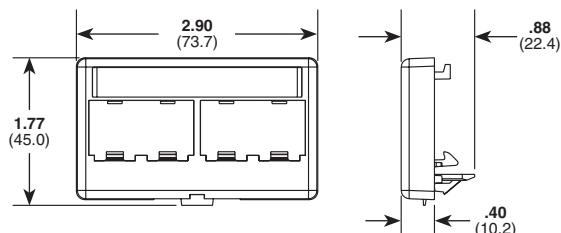
2 Module Space Sloped (CFFPA2)



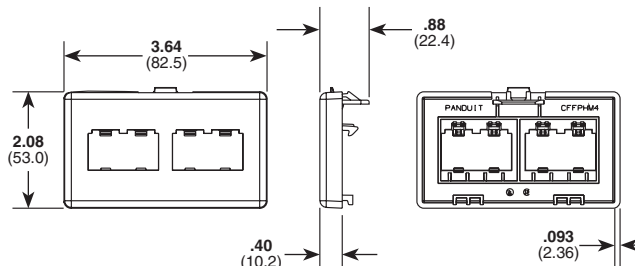
Extender (MFFPE)



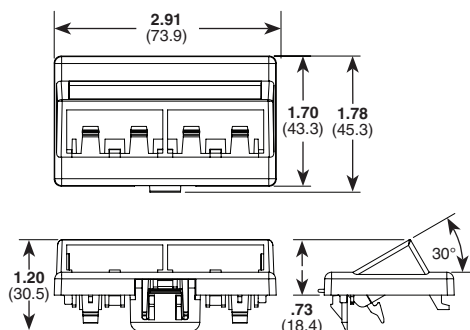
4 Module Space (CFFP4 & CFFPL4)



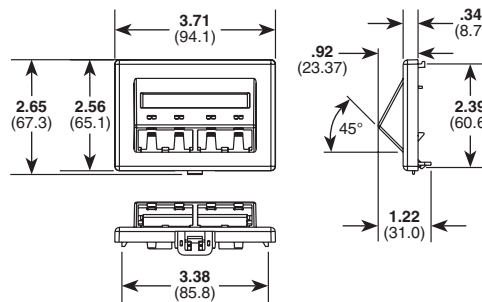
4 Module Space Herman Miller^ (CFFPHM4)



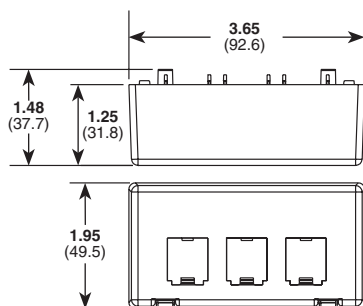
4 Module Space Sloped with labels (CFFPLA4)



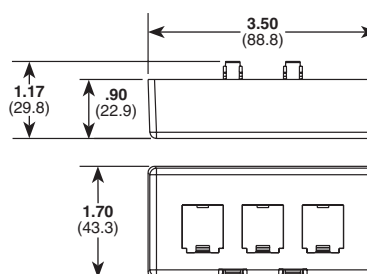
4 Module Space Sloped Herman Miller^ Ethospace Beltline (CFFPEBSL4)
