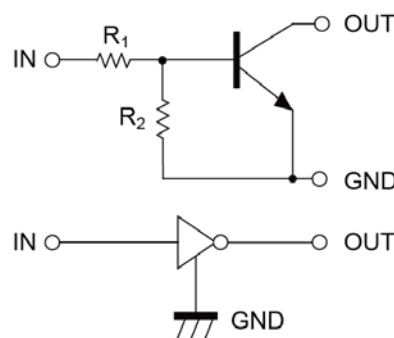

(ON characteristics)

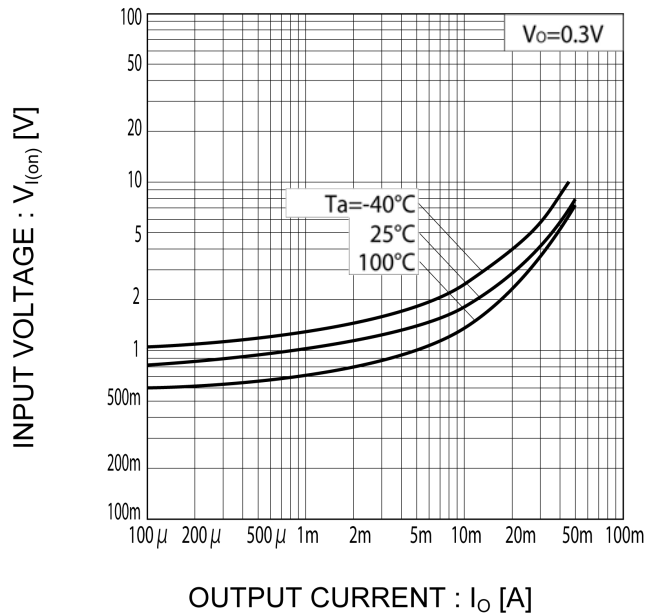


Fig.2 Output current vs. input voltage
(OFF characteristics)

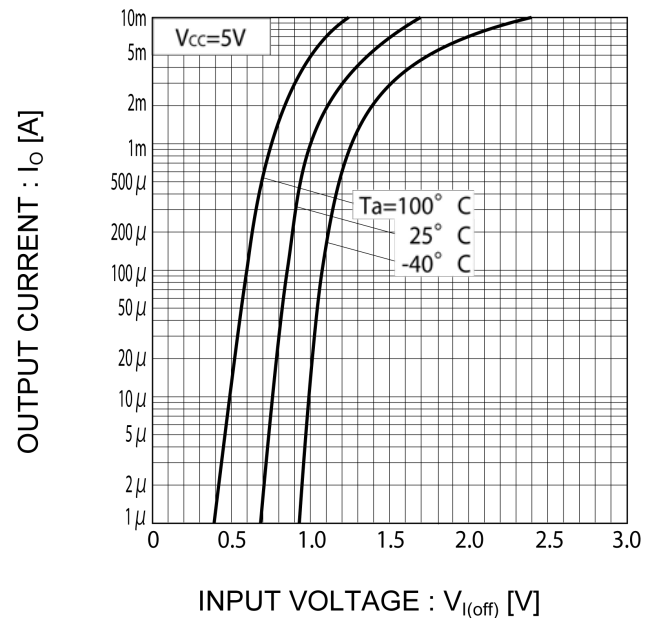


Fig.3 Output current vs. output voltage

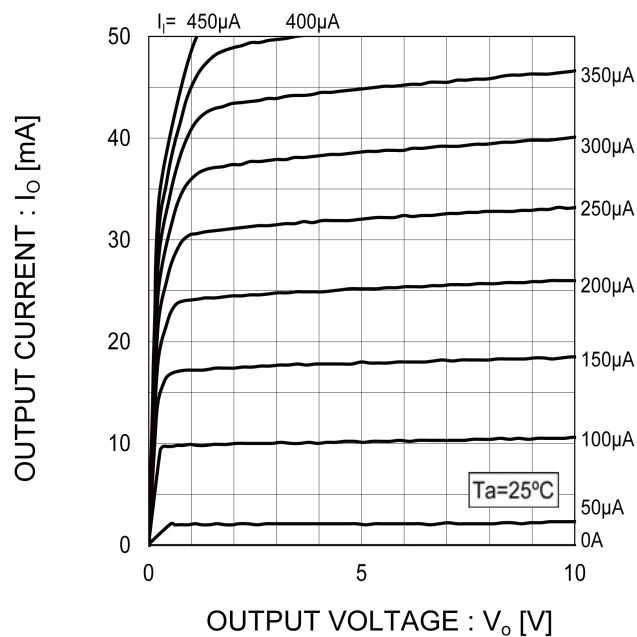
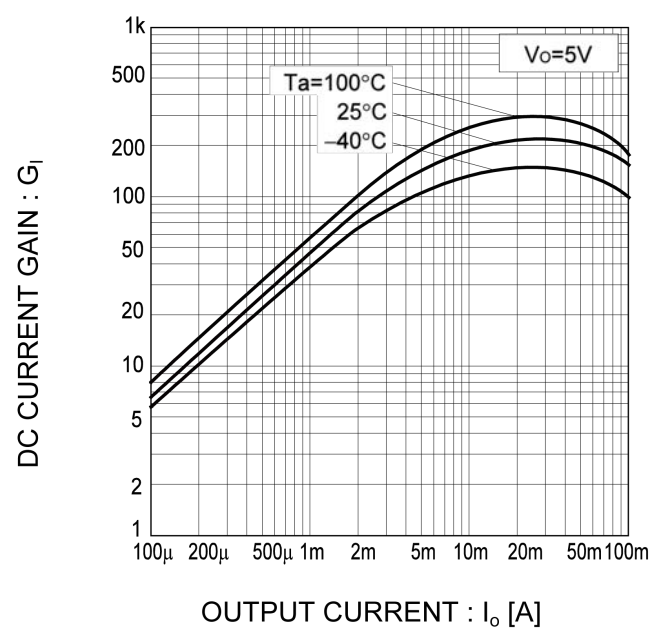
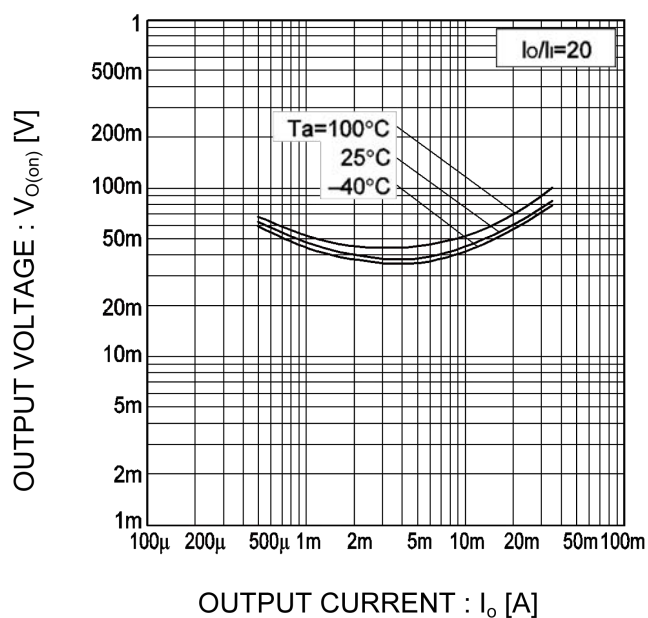


Fig.4 DC current gain vs. output current

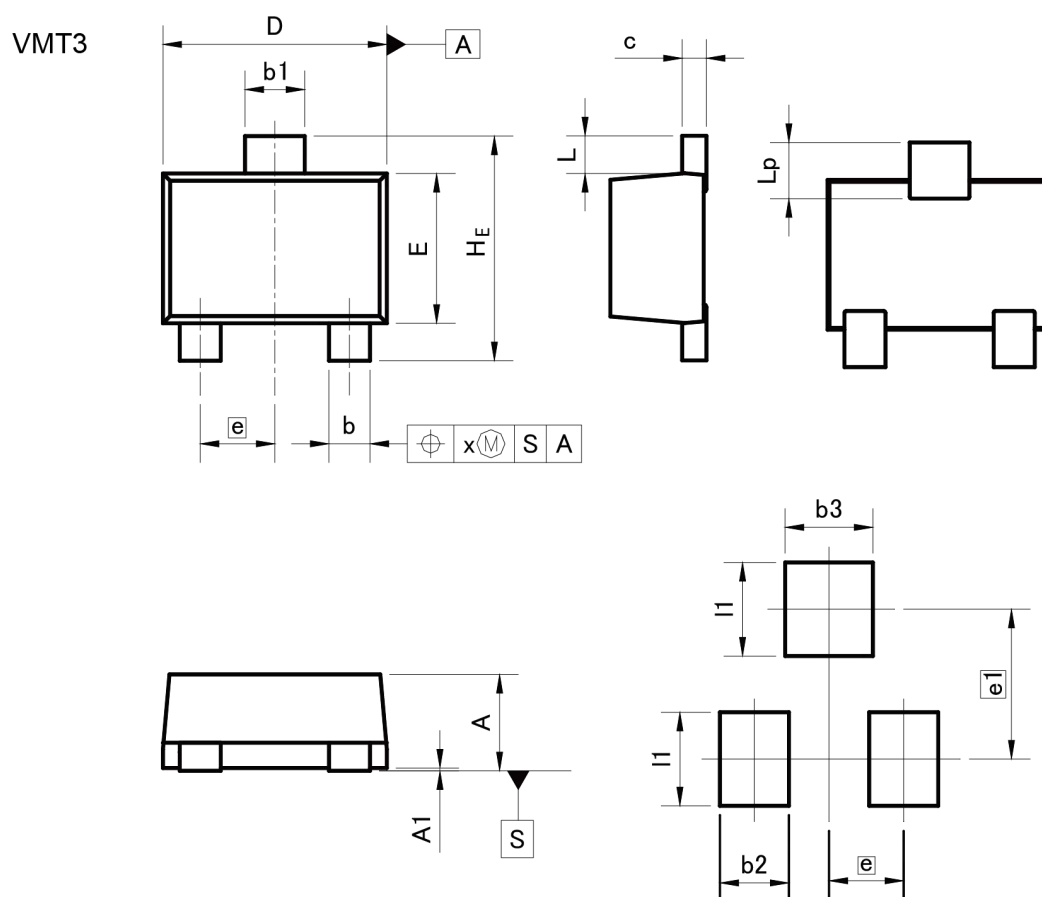


●Electrical characteristic curves ($T_a = 25^\circ\text{C}$)

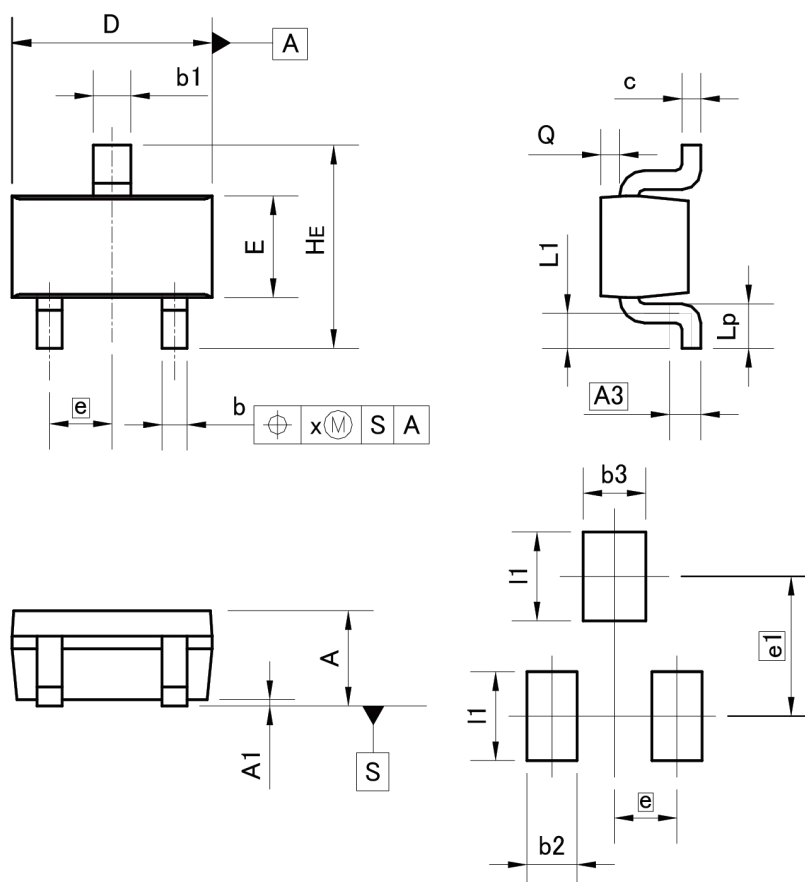

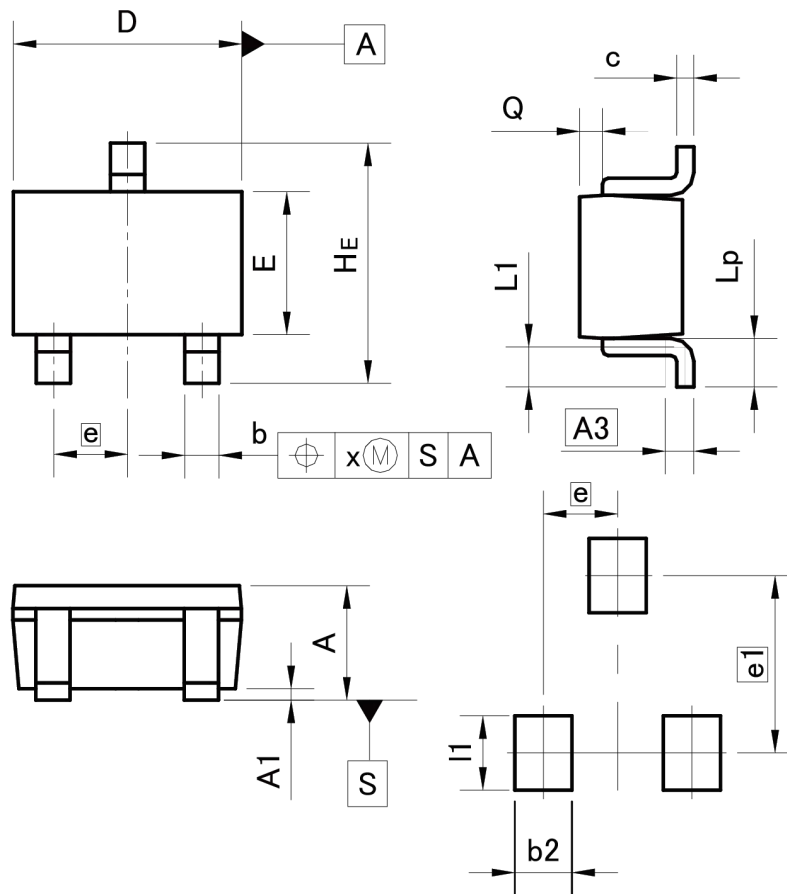

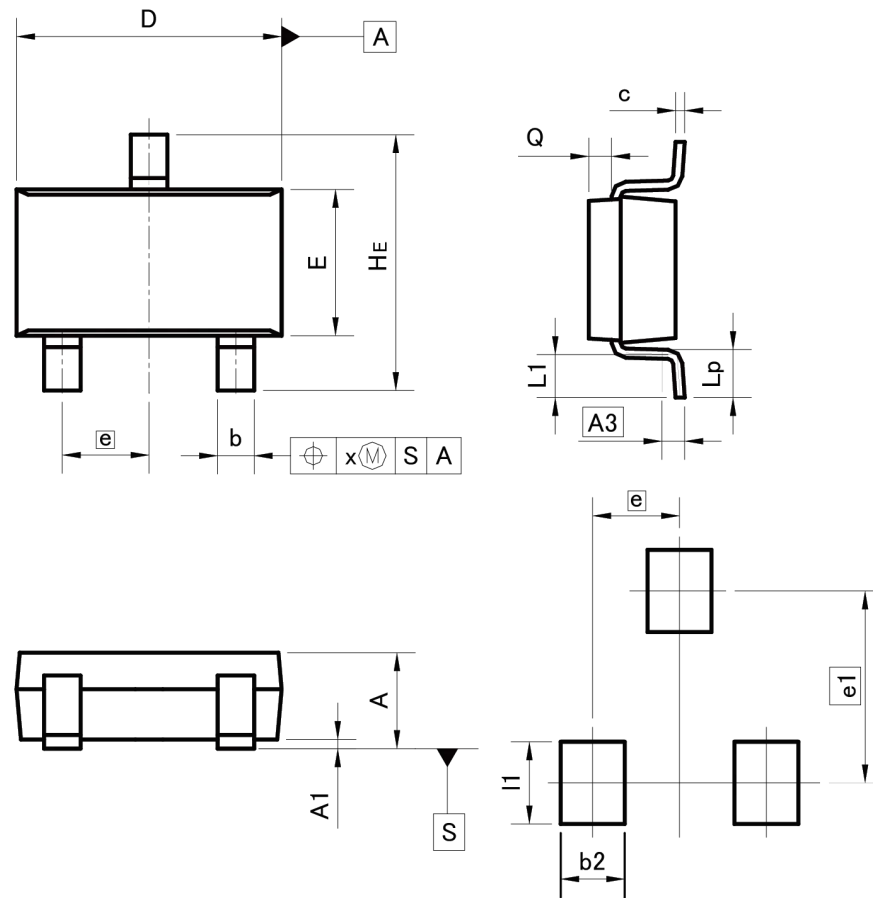
