


Figure 1. Forward Current Derating Curve




Figure 2. Foward Voltage Characteristics




Figure 3. Total Capacitance





Figure 4. Reverse Current vs. Reverse Voltage




Figure 5. Reverse Recovery Time Characteristic and Test Circuit Diagram




Figure 6. 2-LEAD, SMC, JEDEC DO-214, VARIATION AB (ACTIVE)
