

Internal Structure





Suggested Solder Pad Layout






Typical Performance Characteristics (TA=25°C unless otherwise Specified)




Junction Capacitance vs. Reverse Voltage




Peak Pulse Power vs. Pulse Time




Clamping Voltage vs. Peak Pulse Current
