Finisar's 40km FTLX1612M3BCL Small Form Factor 10Gb/s XFP transceivers comply with the current XFP Multi-Source Agreement (MSA) Specification¹. They also comply with SONET OC-192 IR-2, OC-192 IR-3, SDH STM S-64.2b, STM S-64.3b as well as with 10-Gigabit Ethernet 10GBASE-ER/EW per IEEE 802.3ae and 40km 10G Fibre Channel applications. Digital diagnostics functions are available via a 2-wire serial interface, as specified in the XFP MSA. The transceiver is RoHS compliant and lead free per Directive 2002/95/EC³, and Finisar Application Note AN-2038⁴.




Diagram of Host Board Connector Block Pin Numbers and Names

IV. Optical Characteristics (T_{OP} = -5 to 75°C, V_{CC5} = 4.75 to 5.25 Volts)

Please note that the Transmitter of the FTLX1612M3BCL becomes operational within 5 seconds of power-up. This is due to the time required for the EML to reach its optimum operating temperature.

 - Use bit 111.0 to enable/disable Rx CDR (“1” to bypass and “0” to engage)
 By default, the CDR devices shall be engaged on power cycle or module reset.

VIII. Digital Diagnostics Functions

As defined by the XFP MSA¹, Finisar XFP transceivers provide digital diagnostic functions via a 2-wire serial interface, which allows real-time access to the following operating parameters:

- Transceiver temperature
- Laser bias current
- Transmitted optical power
- Received optical power
- Transceiver supply voltage


It also provides a sophisticated system of alarm and warning flags, which may be used to alert end-users when particular operating parameters are outside of a factory-set normal range.

The operating and diagnostics information is monitored and reported by a Digital Diagnostics Transceiver Controller (DDTC) inside the transceiver, which is accessed through the 2-wire serial interface. When the serial protocol is activated, the serial clock signal (SCL pin) is generated by the host. The positive edge clocks data into the XFP transceiver into those segments of its memory map that are not write-protected. The negative edge clocks data from the XFP transceiver. The serial data signal (SDA pin) is bi-directional for serial data transfer. The host uses SDA in conjunction with SCL to mark the start and end of serial protocol activation. The memories are organized as a series of 8-bit data words that can be addressed individually or sequentially. The 2-wire serial interface provides sequential or random access to the 8 bit parameters, addressed from 000h to the maximum address of the memory.


IX. Mechanical Specifications

Finisar’s XFP transceivers are compliant with the dimensions defined by the XFP Multi-Sourcing Agreement (MSA).




XFP Transceiver (dimensions are in mm)


