






Fig. 1 - Max. Forward Current Derating Curve




Fig. 2 - Max. Non-Repetitive Peak Forward Surge Current Per Diode




Fig. 3 - Typical Instantaneous Forward Characteristics Per Diode




Fig. 4 - Typical Reverse Leakage Characteristics Per Diode





Fig. 5 - Typical Junction Capacitance Per Diode
