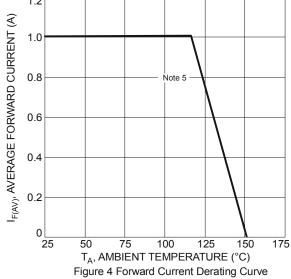








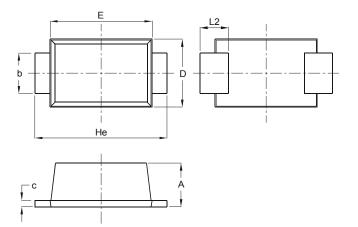






Package Outline Dimensions

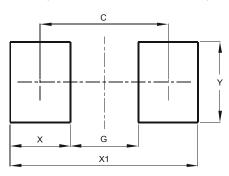
