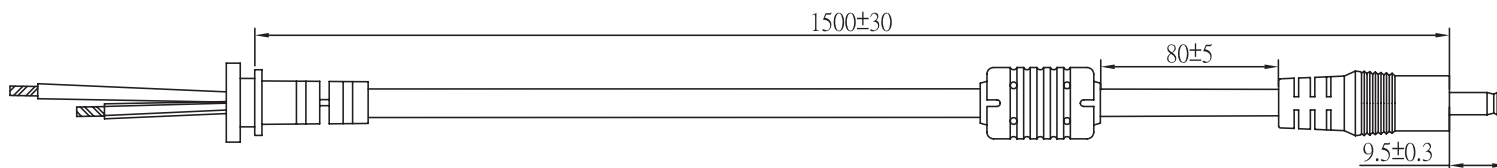

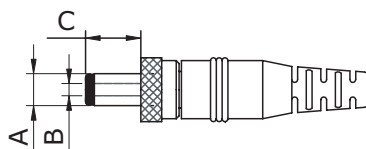
Straight Plug

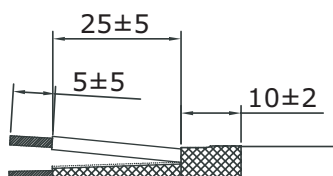

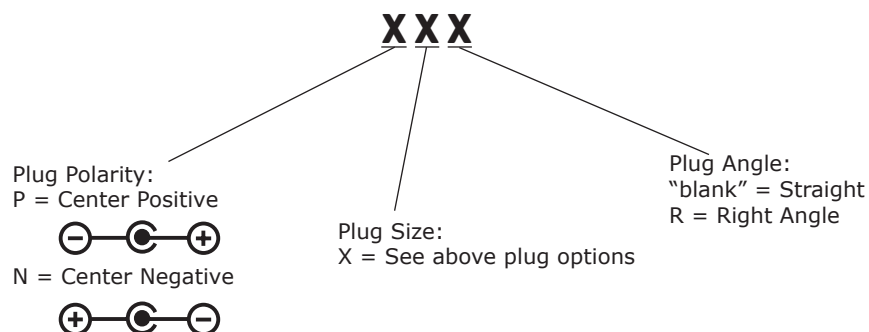
