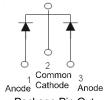

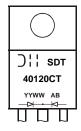

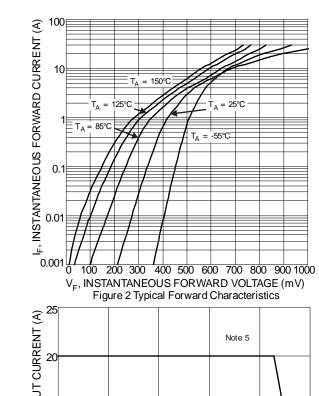

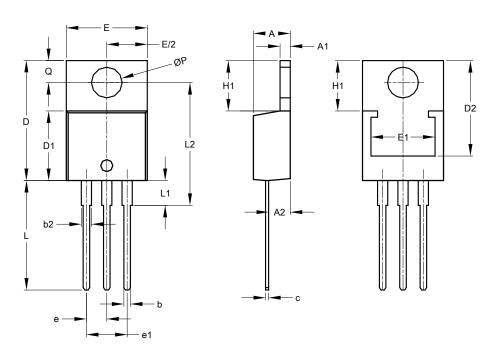
Figure 4 Forward Current Derating Curve
