


SN54F02 . . . FK PACKAGE (TOP VIEW)

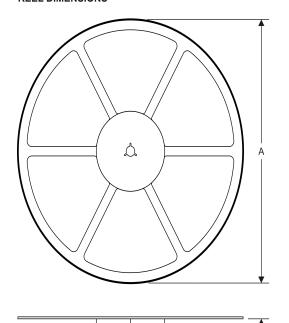


