

DESCRIPTION

These products are miniaturized IR receiver modules for infrared remote control systems. A PIN diode and a preamplifier are assembled on a leadframe, the epoxy package contains an IR filter.

The demodulated output signal can be directly connected to a microprocessor for decoding.

The TSOP584.. series devices are optimized to suppress almost all spurious pulses from Wi-Fi and CFL sources. They may suppress some data signals if continuously transmitted.


The TSOP582.. series devices are provided primarily for compatibility with old AGC2 designs. New designs should prefer the TSOP584.. series containing the newer AGC4.

These components have not been qualified according to automotive specifications.



 R_1 and C_1 recommended to reduce supply ripple for $V_S < 2.8 \text{ V}$






Fig. 2 - Pulse Length and Sensitivity in Dark Ambient






Fig. 3 - Output Function




Fig. 4 - Output Pulse Diagram




Fig. 5 - Frequency Dependence of Responsivity




Fig. 6 - Sensitivity in Bright Ambient




Fig. 7 - Sensitivity vs. Supply Voltage Disturbances




Fig. 8 - Sensitivity vs. Electric Field Disturbances




Fig. 9 - Max. Envelope Duty Cycle vs. Burst Length




Fig. 10 - Sensitivity vs. Ambient Temperature




Fig. 11 - Relative Spectral Sensitivity vs. Wavelength




Fig. 12 - Horizontal Directivity




Fig. 13 - Vertical Directivity




Fig. 14 - Sensitivity vs. Supply Voltage



SUITABLE DATA FORMAT

This series is designed to suppress spurious output pulses due to noise or disturbance signals. The devices can distinguish data signals from noise due to differences in frequency, burst length, and envelope duty cycle. The data signal should be close to the device's band-pass center frequency (e.g. 38 kHz) and fulfill the conditions in the table below.

When a data signal is applied to the product in the presence of a disturbance, the sensitivity of the receiver is automatically reduced by the AGC to insure that no spurious pulses are present at the receiver's output.

Some examples which are suppressed are:

- DC light (e.g. from tungsten bulbs sunlight)
- · Continuous signals at any frequency




Fig. 15 - IR Disturbance from Fluorescent Lamp with Low Modulation





Fig. 16 - IR Disturbance from Fluorescent Lamp with High Modulation

- Strongly or weakly modulated noise from fluorescent lamps with electronic ballasts (see Fig. 15 or Fig. 16)
- 2.4 GHz and 5 GHz Wi-Fi
