




Fig. 1 - Maximum Forward Voltage Drop Characteristics




Fig. 1 - Typical Values of Reverse Current vs. Reverse Voltage




Fig. 2 - Typical Junction Capacitance vs. Reverse Voltage




Fig. 3 - Maximum Thermal Impedance Z_{thJC} Characteristics







Fig. 2 - Maximum Allowable Case Temperature vs. Average Forward Current

Fig. 5 - Typical Reverse Recovery Time vs. dl_F/dt




Fig. 4 - Forward Power Loss Characteristics




Fig. 6 - Typical Stored Charge vs. dI_F/dt





Fig. 9 - Reverse Recovery Parameter Test Circuit

$$Q_{rr} = \frac{t_{rr} \times I_{RRM}}{2}$$




