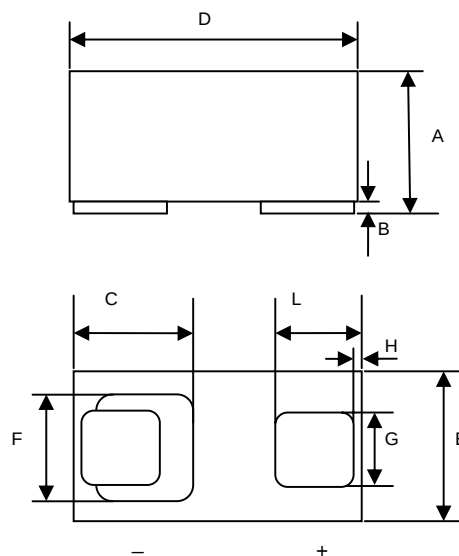

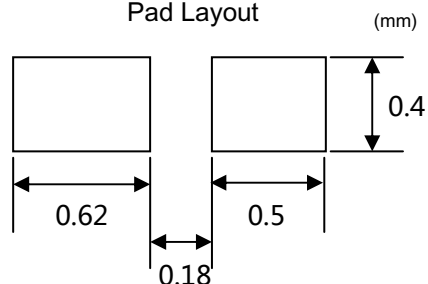

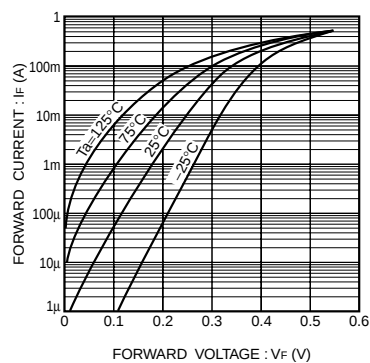


Fig. 1 Forward characteristics

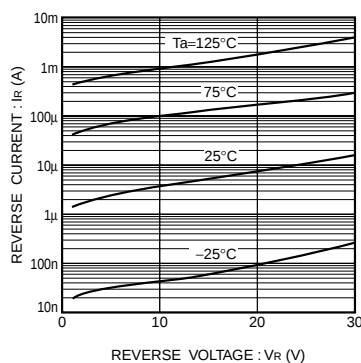
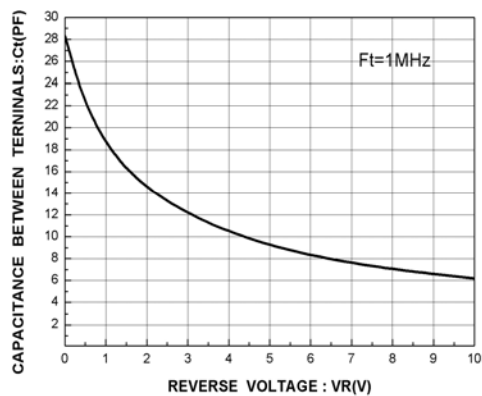


Fig. 2 Reverse characteristics
