


Figure 1. Static Characteristic




Figure 3. Base-Emitter Saturation Voltage Collector-Emitter Saturation Voltage

I_c[A], COLLECTOR CURRENT





Figure 5. Collector Output Capacitance



 $I_c[A]$, COLLECTOR CURRENT Figure 2. DC current Gain





Figure 4. Base-Emitter On Voltage





Figure 7. Power Derating
