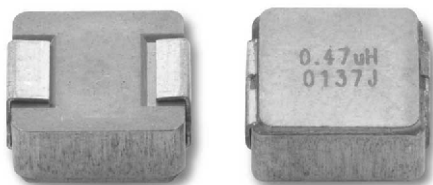

Notes
