


Fig. 1 - Peak Pulse Power Rating Curve




Fig. 4 - Typical Junction Capacitance




Fig. 2 - Pulse Power or Current vs. Initial Junction Temperature




Fig. 5 - Maximum Non-Repetitive/Peak Forward Surge Current




Fig. 3 - Pulse Waveform





Fig. 6 - Power Derating Curve
